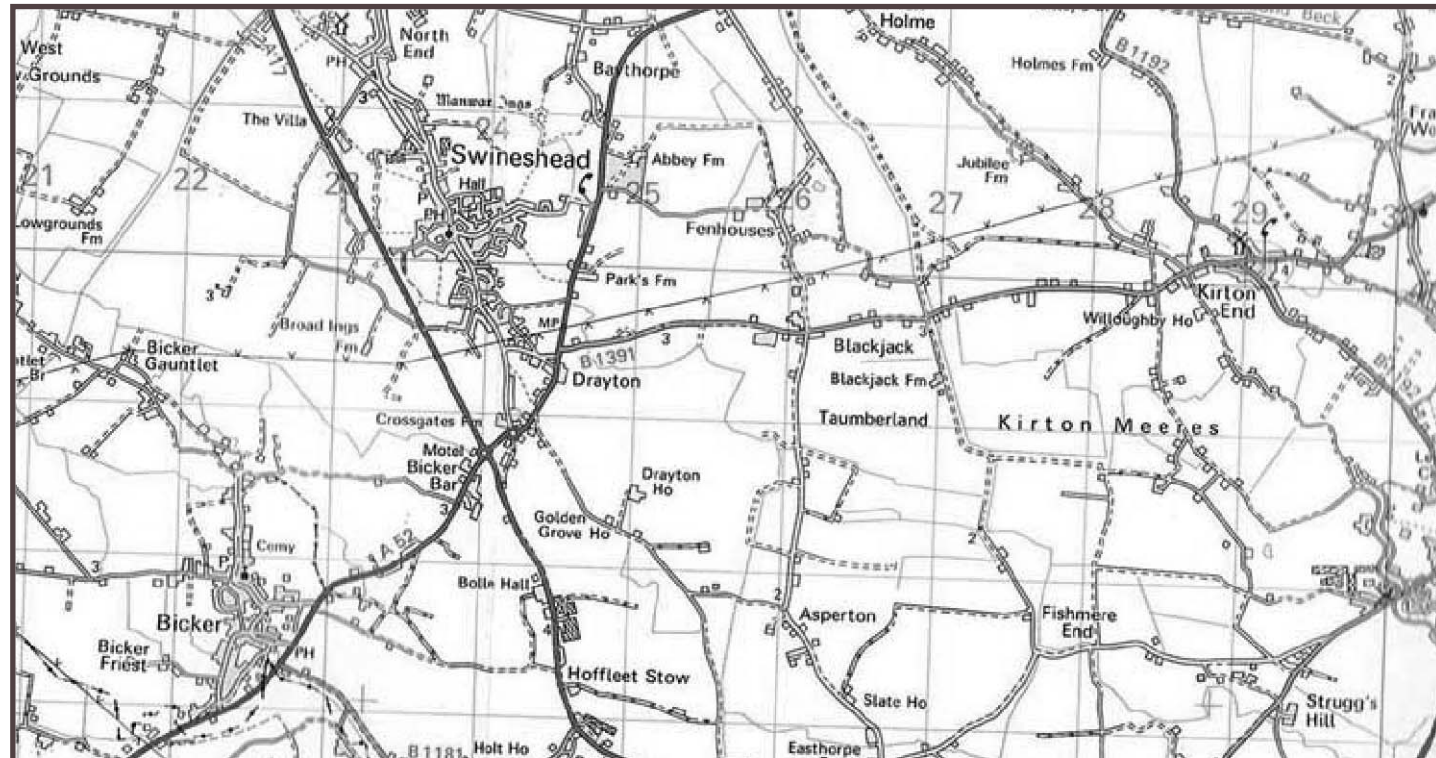

CONDITIONS OF SALE

- Entry:** The auctioneers reserve the right to refuse acceptance of any lot either on receipt of the entry or delivery.
- Trade Entries:** Entries will only be accepted from Dealers and Traders without a reserve.
- Delivery of Lots:** Entries may be delivered to the sale site on the Wednesday between 8.30am and 5pm and Thursday between 8.30am and 12noon. NO ENTRIES MAY BE DELIVERED ON THE FRIDAY BEFORE THE SALE. Registration Books, Instruction Manuals and other relevant documentation should be delivered with the Lots.
- Hire Purchase:** Articles which are subject to a Hire Purchase Agreement will not be accepted unless full details of the Agreement are disclosed to the Auctioneers at least 21 days before the sale and necessary consents to the sale have been obtained.
- Liability:** The Auctioneers accept no liability whatsoever in respect of any loss of or damage to any item entered for the sale. Items are at all times at the risk of the owner who should ensure that there is relevant insurance cover.
- Reserve Prices:** Any reserve price must be notified to the Auctioneers in writing at least 24 hours prior to the sale otherwise no responsibility can be accepted. The Auctioneers will not accept a reserve price of less than £50.00 on any Lot.
- Commission:** Commission is charged to the Vendors at the rate of 8% of the sale price. This commission will also be charged on Lots which are bought in. The minimum commission is £10 per Lot. This minimum commission will only apply to Lots which sell for under £50.00. The commission charge is subject to VAT and it includes all advertising and promotional costs.
- Clearance:** No Lots are to be delivered to the sale site until 4 days before the sale and all unsold Lots are to be removed within 7 days after the sale. There will be no entry to the sale site on a Sunday. Any Lots remaining after a week will be sold or otherwise disposed of by the Auctioneers, without notice, at the expense of the owner.
- Conditions of Sale:** The full Conditions of Sale will be on display at the sale site or can be forwarded upon request. The Auctioneers will not be liable for any default on the part of any Purchaser or Vendor.
- Valued Added Tax:** The Auctioneers will collect VAT from Purchasers on Lots being sold by VAT registered Vendors and will pay it over to such Vendors, who should account for it in the usual way.
- Electrical Items:** The Department of Trade & Industry has made it an offence for unsafe second hand electrical items to be sold at Auction. The offence carries a £4,000 fine per item. In order to cover you as the Vendor and ourselves as the selling Auctioneers a qualified electrician will test the items on the day before the Sale. However, if, for whatever reason, they fail their safety test, the electrician's decision is final, and they will be labelled as "SCRAP" and will have to be sold as SCRAP.
