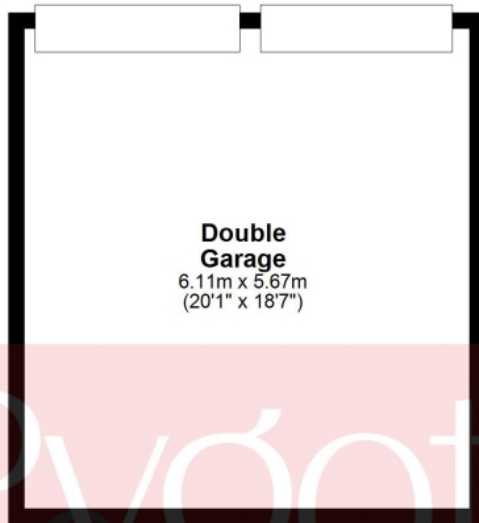
Agent's Note: A detached double garage is currently situated on the plot; however, the existing planning permission requires its removal to facilitate the construction of the new dwelling.

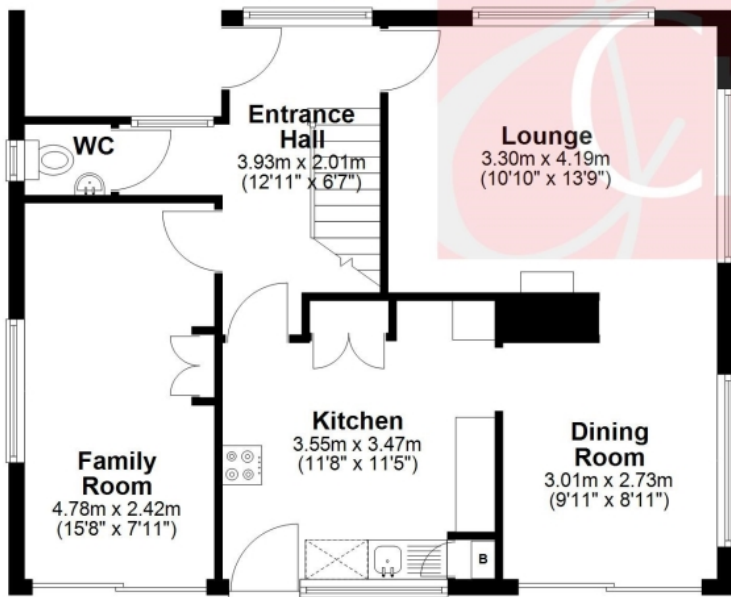

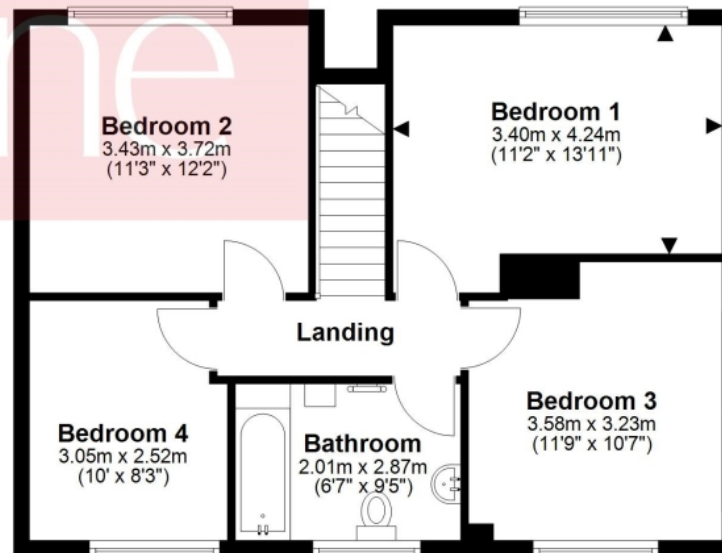
